

The total number of people directly and indirectly benefiting from the services from NGP is approximately over 65000 since from 1994.

#### 1. Navjeevan Balaksharam (Since 2010)

Navjeevan Balakashram is running since 2010 at pathardi in Ahmednagar District with support of Women's and Child Development department Maharashtra Government for 100 Children. Navjeevan Balakashram is a home for homeless, needy and orphaned children. The term Navjeevan refers to a new life. This organization is dedicated to work towards giving new life and opportunities to orphan and destitute children, irrespective of their religion or caste. Mainstreaming the Orphan children in the national building by providing care, support & protection through shelter, food, and education is our mission.

#### PROJECTS IMPLEMENTED IN PAST

#### 1. NABARD - IGWDP (2001-12)

NGP has implemented NABARD supported Indo German watershed development project in Ahmednagar district of Maharashtra state from 2004 to 2012. NGP has successfully completed four IGWDP projects i.e. Devala, Shekte, Boralwadi and Borseweadi comprises total area of 4513.28 ha with 680 households & 5196 Population.

#### 2. Community Action for Poverty Alleviation (CAPA) (2002-03)

NGP has worked for construction of check dams and drinking water supply schemes for 4 villages of Ahmednagar district have been implemented in year 2002-2003 under the Community Action for Poverty Alleviation project (CAPA) funded by Watershed Organization Trust (WOTR). CAPA project has been implemented in Kokatwadi, Ladjalgaon, Shekte and Borsewadi villages. Interventions through CAPA project benefited total 4182 rural people and it has been successfully completed within period of two years.

#### 3. Apale Pani (Water supply scheme) (2007-08)

'Apale Pani' project has been implemented in 8 villages in Shirur block of Pune District with the support of Zila Panchayat, Pune. NGP is awarded by Department of rural development, Government of Maharashtra as most crucial project for drinking water. NGP played a role of facilitating agency for capacity building and social awareness through various rural development tools like village meetings, trainings & exposure visits and participatory rural appraisal. This project made drinking water available to more than 10721 populations in eight villages.

#### 4. Apale Pani (Water supply scheme) (2007-08)

This Project was implemented in 09 villages from Rahuri block of Ahmednagar District. NGP had worked on awareness generation and capacity building of community people about drinking water. This project was implemented with the collaboration of Zila Panchayat, Ahmednagar. Project had covered over 10820 populations as the target group of the project.

#### 5. Janashri BimaYojana for labour (2007-08)

Worked with unorganized workers in Ahmednagar district as an intermediary organization under Janshree Insurance Scheme in association with the Assistant Labor Commissioner, Ahmednagar. Organization had covered over 525 unorganized workers in Ahmednagar district.

#### 6. Project Training Organisation (PTO) for IWMP (2015-16)

Yashada has awarded NGP to be a PTO in Pathadi taluka of Ahmednagar to impart trainings to VWC, and other local level organizations in 13 villages. The Trainings comprise of Exposure and Orientation to the Beneficiaries about schemes in 1955 beneficiaries were imputed trainings under this head.

#### 7. Project Training Organisation (PTO) for WGDP (2014-15)

Yashada has awarded NGP to be a project training organization (PTO) in Western Ghat Development Programme for two watersheds in Akole block of Ahmednagar district. Public awareness, training programs and exposure visits were organized in the project village. Through this project NGP ware able to trained over 633 People in the project area.

#### 8. ITC India- Mission SuneharaKal Project (2011-2013)

Under the Corporate Social Responsibility (CSR) of the ITC India, Mission SuneharaKal project has been implemented in the 10 villages of Ujjain district in the state of Madhya Pradesh. The key interventions of the projects are capacity building of community, soil and water conservation, water harvesting and agriculture development. This project was benefited over 11242 populations in the project villages.

#### 9. Youth Development Project (2012-13)

With the help of Central Government, the Youth Development Project was implemented in Ahmednagar district in 2012 with the collaboration of Nehru Yuva Kendra.

#### 10. R.C.H. -Reproductive Child Health Scheme (2006-07)

Under the Reproductive Child Health Scheme, NGP had worked in 4 villages of Rahuri and Rahata block on mass awareness generation for promotion of health. This project was implemented in collaboration with Zila Panchayat, Ahmednagar. NGP able to reach 3852 people in the project area through RCH.

#### 11. Livelihood Resource Agency (LRA) – (2015-16)

NGP has been appointed as Livelihood Resource Agency (LRA) to livelihood training program for 4 cluster in Solapur district under integrated watershed development programme (IWMP). This project were implemented with collaboration of YASHADA. NGP trained 200 people through this project. Training was given to people about Goat Rearing, Cow Rearing, Dairy industry etc.

#### 12. Maharashtra Rural Employment Guarantee Scheme (2008-09)

NGP have been working as the technical service providers under the Maharashtra Rural Employment Guarantee Scheme for the Rahuri and Pathardi blocks of Ahmadnagar district in the year 2008.

#### 13. Suvarn Jayanti Self Employment Scheme (2005-06)

In collaboration with DRDA, under the Suvarn Jayanti Self Employment Scheme, in 13 villages of Rahuri & Nagar have been formed & set up women's Self Help groups. As part of this project NGP ware able to form over 75 active SHG groups in the project villages.
